APPLICATION NOTES

- 1. Qualifying ancestor The term "Farmer" shall denote any person engaged in agriculture between July 4th, 1776 and July 4th, 1914.
- SHORT FORM Applications Used for your proposed farmer when lineage from a previously approved application exists. The short form will be used for A PROPOSED FARMER WHO IS DOCUMENTED ON AN APPROVED APPLICATION FROM ANOTHER LINEAGE ORGANIZATION. You may use ANY generation of that line; it does not need to be the approved ancestor on the application.
 - Attach a "record copy" of your approved application from NSDAR, NSSAR, etc. NOT JUST THE MEMBER NUMBER.
 - Print the SHORT FORM application on one sheet of letter size paper (quality copy paper).
 - Include a record copy of your approved application from another lineage organization.
 - If using a verified application, indicate the originating society and the pertinent information from the ancestor's generation on the form. Approved applications can be NSSAR, General Society 1812, NSDAR and others which required generation proofs.
 - Include one proof showing your ancestor engaged in the field of agriculture (this can be a census, will, etc.)
- 3. LONG FORM Application Used when lineage from a previously approved application cannot be used.
 - Print the LONG FORM application on letter size paper **double-sided**.
 - Include all information and references for each generation back to the qualifying ancestor.
 - Provide documentation for each fact stated in each generation and write the generation number on each piece of documentation in red in the upper right-hand corner of the proof. Documentation for each generation of the lineage must identify the individual's name, including spouse(s), and must establish the relationship from one generation to another. All documentation submitted shall conform to the present-day standards of evidence.
 - Vital records providing FULL dates with proof of birth, marriage, and death (where applicable) must be furnished for generations one through three.
 - All dates should be formatted as dd Mon yyyy (e.g. 31 Jan 2021).
 - When documentation cannot be provided, or exact dates are unavailable, approximate dates using "circa" or "about." For example, "ca" 1777, or "about"1777, or "abt" 1777.
 - Include copies of all references cited. Complete citations are required to include author, the title of the book, date of publication, volume, and page or pages. Copies of sources must be legible.
- 4. Proof documents:
 - <u>Underline in red</u> all pertinent information on each piece of documentation
 - Include generation numbers in upper, right corner of each document.
 - Proof documents may be submitted on generic copy paper.
 - Do not fold when mailing. Do not use paperclips or staples.
- 5. Applications must be typed and must have original signatures of the applicant. If the application is accepted, a verified copy will be sent to the Member via electronic attachment.
- 6. Using Other Lineage Society Applications as Proof:
 - Information from applications from the following lineage societies have been approved for use as proof for any generation on the application, provided acceptable proof was supplied for the information on that application: National Society Daughters of the American Revolution, National Society Sons of the American Revolution, The Society of the Cincinnati, Jamestowne Society, General Society of Mayflower Descendants, National Society Daughters of the American Colonists, National Society Sons and Daughters of the Pilgrims, The National Society Colonial Dames XVII Century, The Colonial Dames of America, National Society Daughters of Colonial Wars, General Society of Colonial Wars
 - Please provide a record copy of the approved lineage society application with the NSDOAF application and cite it as the source where applicable.
- 7. Applications will not be reviewed without all components; the application, proofs (which might be a copy of another lineage organizations approved application), proof of the farmer and a check in the amount of \$300 (or the appropriate funds).

APPLICATION NOTES (Cont'd.)

- 8. Section 1. Eligibility. A. Men and women 18 years of age or older who are lineal descendants of a "farmer" within the present boundaries comprising the forty-eight (48) contiguous continental states of the United States of America between July 4th, 1776 July 4th, 1914, are eligible for membership in this society. B. A farmer is a person engaged in varying capacities in the agricultural industry, including but not being limited to farmer, rancher, farm hand or yeoman. The fact that an ancestor has another profession or occupation does not prevent that ancestor from being a "farmer" where requirements are met. A census record citing the ancestor's occupation as farmer is an example of sufficient evidence of the definition of "farmer". C. Membership inquiries are welcome. An invitation to apply may be extended by the President National to persons descended from a farmer as herein above defined. D. Subject to the requirements set forth in this Article, it is the policy of the Society not to discriminate on any basis.
